

Visitation Plan
GUIDANCE FOR VISITING RESIDENTS AT FELLOWSHIP COMMUNITY
Manor, Terrace and Villa Buildings

1. Visitation rules and core infection control principles:

- Enter through the Terrace front entrance for screening
- Maximum of 2 visitors per resident at a time, children are allowed accompanied by an adult, however the 2-person rule still applies (2 adults **or** 1 adult and 1 child)
- Utilize the electronic kiosk to complete COVID screening process, visitor check in and obtain visitor ID badge
- Unvaccinated residents & unvaccinated visitors must always wear a mask/ face covering that is properly fitted over the nose and mouth at all times. This also applies to children over 2 years of age. A 6 ft. physical distance must also be maintained. There are no exceptions. Mask wearing will be strictly enforced.
- Fully vaccinated residents & their fully vaccinated visitors can choose to have close contact (physical touch) and to not wear their face masks if they are alone in a private room or visitation area. However, masks must be in place when they are in other parts of the buildings and whenever other staff/residents/ or visitors are in the space.
- 6 ft. physical distance is to be maintained from other residents and staff
- Use hand sanitizer before and after visitation
- Visitor ID badge must be on and visible during the visit
- Stay in resident room (private rooms only) or common areas only
- Residents who have a roommate are to take their visit in a common area
- Weather permitting, outdoor visits are highly encouraged
- Sign out at the end of the visit
- All visitation areas will be disinfected after each visit.
- Non – compliance will result in termination of visitation privileges
- Stay home if ill, were exposure to anyone with COVID 19 in the past 14 days, or traveled internationally in the past 14 days.

2. Additional information:

- Refrain from discussing private health information during the visit
- Weather permitting, outdoors visits are preferred and can be requested as long as the resident is agreeable and can be safely transported. Fully vaccinated residents and visitors do not need a mask outdoors if they are in a private space and physically distanced from other residents/visitors/staff.

- There is no wi-fi available outdoors so if you use your cell phone during the visit you will be using your data plan.
- Fully vaccinated refers to a person who is greater than 2 weeks post their second vaccine dose or 2 weeks' post receiving a single dose vaccine.

3. CMS Visitation exceptions & information:

Facilities should allow indoor visitation for all residents (regardless of vaccination status), except for a few circumstances when visitation should be limited due to a high risk of COVID-19 transmission (note: compassionate care visits should be permitted at all times). These scenarios include limiting indoor visitation for:

- Unvaccinated residents, if the nursing home's COVID-19 county positivity rate is >10% **and** <70% of residents in the facility are fully vaccinated;
- Residents with confirmed COVID-19 infection, whether vaccinated or unvaccinated until they have met the criteria to discontinue Transmission-Based Precautions; or
- Residents in quarantine, whether vaccinated or unvaccinated, until they have met criteria for release from quarantine.

When both the resident and all visitors are fully vaccinated, and while alone in the patient/resident's room or the designated visitation room, patients/residents and their visitor(s) can choose to have close contact (including touch) and to not wear source control (masks).
